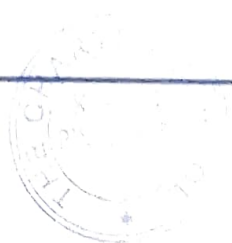

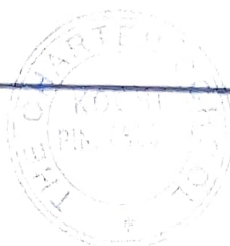

Terms & Conditions Governing the Fee Concession Policy:

1. Only one concession from the categories 2, 3 & 4 can be availed in any academic year. No two concessions can be availed/combined together.
2. The concession amount is strictly restricted/calculated on the Tuition Fee/ Admission fee as per the Fee Structure of the respective grade published during every academic year. All other applicable fees are payable.
3. Relevant supporting documents for availing the concession will have to be submitted at the time of admissions.
4. In the case of corporate concession, the same is valid only for one academic year.
Relevant supporting documents will have to be submitted in the subsequent year. (If applicable).
 - a. Copy of ID card
 - b. Letter from the company stating that the employee is still working there
5. All decisions for the grant of concessions are at the sole discretion of the management.
6. Admissions department will collect all necessary documents required for each of the concessions and send a copy of the same to the accounts department. A copy of all these documents will have to be filed in the student file too.
7. Intimation of concession approval will be made in writing through appropriate channels. No oral confirmation will be considered.
8. The management holds the final right to grant or deny concessions.
